






INTRODUCING EQUANS

Conducting a Legionella Risk Assessment (LRA) is a legal requirement under the Health and Safety at Work Act 1974. We have a highly skilled City & Guilds trained team of legionella risk assessors able to undertake LRA's on all domestic water systems.



2. WATER TREATMENT SERVICES


Our comprehensive range of services are designed to provide ongoing monitoring regimes to maximise efficiency, longevity and reduce the risk of legionella and other pathogens in your water-treatment systems. We develop tailored schedules of services for your premises, which can include corrosion monitoring, preventative maintenance and chemical flushing for closed water systems, as well as treatment, in full compliance with BSRIA recommendations. We also provide full analysis, maintenance and refurbishment of cooling towers and steam boilers. Our dedicated operational teams have years of experience in managing critical systems and supporting legionella control.



3. HOT & COLD WATER MONITORING SERVICES

We provide a full suite of water hygiene services to monitor and maintain domestic water distribution systems across all building types and sectors, ensuring you comply with the Health and Safety Executive's Approved Code of Practice (ACOP) L8 and Technical Guidance HSG274 Part 2 & 3.









4. CLEANING AND DISINFECTION SERVICES

Our experienced engineers carry out cleaning and chemical disinfections of storage cisterns and water systems in accordance with The Health and Safety Executive (HSE) and British standards and specifications ACOP L8 HSG 274 Parts 1, 2 & 3, PD 855468 and BS8558.

We provide impartial, unbiased, and practical advice and support to enable our stakeholders and clients to operate their buildings safely, efficiently and in full compliance. We have a wealth of experience across a broad cross-section of sites throughout the UK.



6. LEGIONELLA MONITORING SERVICES

We offer tailored and bespoke regimes to control and manage risks from legionella and other microbiological pathogens in your buildings, ensuring you comply with the Health and Safety Executive's Approved Code of Practice (ACOP) L8 and Technical Guidance HSG274 Parts 1, 2 & 3, plus other best practice guidance such as HTM 04-01 and relevant British Standards. All samples are collected using strict protocols and our partner laboratories (independent and UKAS accredited) carry out tests for many micro-organisms including legionella pneumophila, E.coli, coliforms and pseudomonas aeruginosa.



7. PLANT AND EQUIPMENT SERVICES

We can install a diverse range of equipment to suit each client's exact requirements, including water softeners, a comprehensive selection of filtration products, a broad spectrum of non-chemical systems as well as a broad range of dosing equipment and controls.
